The Governing Body have not appointed any Associate Governors for the Academic Year 2025-26.

The Governing Body appointed the following committees/panels in September 2025 – Appeals, Complaints, Curriculum/Standards, Finance, Headteacher Performance Management, Hearings, Pay Review, Personnel, Premises, Pupil Discipline.

Pay Review Panel– Meets annually as directed by the ratified Pay Policy

Headteacher Performance Management Panel – Meets **annually** and makes a recommendation to Pay Committee regarding Headteacher's Pay decision.
